

December 10, 2019

This is a report of the regular meeting of the Rossville Town Council on Tuesday, December 10, 2019 at 6:30 p.m. at the Rossville Town Hall.

On call of the roll: David Severt and William Croto. Jack Fingerle was absent.

Also present were Travis Harris, Robert Shaffer, and Adrienne Wills, and Michael Meador.

David Severt called the meeting to order and minutes from the previous meeting were approved as presented.

Adrienne Wills appeared before the Council to request an adjustment to the wastewater portion of her utility bill due to a major leak. After discussion, Bill Croto made motion to give a credit of \$125.00 as one time only occurrence, seconded by Dave Severt, and passed by Council.

Travis Harris discussed the rooster issue on E. North St. There was also discussion of amending the nuisance ordinance to address non-plated 5th wheel campers being used within the town limits as a residence.

Ordinance 2019-07, an ordinance amending ordinance 2000 Code §1-1, recodified as §90.11 keeping certain animals, was presented on first reading. Bill Croto made a motion to approve Ordinance 2019-07 on first reading, seconded by Dave Severt, and passed by Council.

Mark Meador appeared before the Council to discuss the street repaving project on W. North St. There is a curb issue at the entrance to the parking area for Meador Accounting. The curb was not cut down to allow parking. It was questioned whether the curb could be shaved down. Council will table until the street superintendent returns from a meeting.

Ordinance 2019-06, an ordinance amending Ordinance 2000 Code §3-5, recodified as §31.01 fixed asset policy, was presented to Council for review. Bill Croto made a motion to approve Ordinance 2019-06, an ordinance to amend the fixed asset ordinance on first reading, seconded by Dave Severt, and passed by Council. Bill Croto made a motion to suspend the rules on the second and third reading of Ordinance 2019-06 to amend the fixed asset ordinance, seconded by Dave Severt, and passed by Council. Bill Croto made a motion to approve Ordinance 2019-06 on second and third readings, seconded by Dave Severt, and passed by Council.

The Amended Capital Improvement Plan for the Town of Rossville was presented to Council for review. Bill Croto made a motion to approve the Amended Capital Improvement Plan on all three readings, seconded by Dave Severt, and passed by Council.

Pat McIlrath informed the Council the health insurance had an 8% increase for the upcoming new year.

Voucher Register was approved and signed.

Dave Severt presented amendments to the personnel policy for review. Dave Severt also stated to let the record show the title for the RAT Van had been delivered to the Town Hall and would be placed in the safe until further decisions have been made regarding the future of the van.
