On call of the roll: David Severt and Jack Fingerle. William Croto was absent. There were no other individuals present from the public.

Dave Severt called the meeting to order and minutes from the previous meeting were approved as presented.

Jack Fingerle made a motion to approve the bonds for Sarah Burkle, Patricia McIlrath, and the Crime Coverage Bond, seconded by Dave Severt, and passed by Council.

Encumbrance Ordinance 2019-08 to trade in and purchase a Woods mower from Rodkey/New Holland in 2020 in the amount of \$9545.00 was presented to Council for review. Jack Fingerle made to motion to approve Encumbrance Ordinance 2019-08, seconded by Dave Severt, and passed by Council.

Ordinance 2019-06, an ordinance amending the fixed asset policy, was presented to Council for approval on second reading. Typographical Amendments to Unified Development Ordinance from Clinton County Area Plan was presented to the Council for review. There were no objections to the amendments. Liz Stitzel will be at the next Council meeting to discuss additional amendments to the Unified Development Ordinance.

Voucher Register was approved and signed.

Amendments to the personnel policy were reviewed and will be approved at the next meeting.
