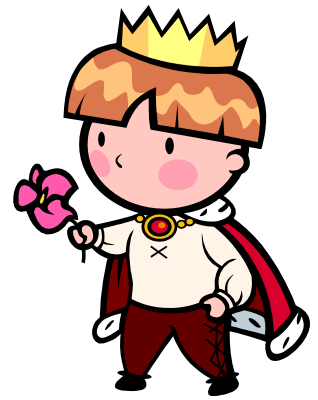

LITTLE MISS AND LITTLE MISTER CONTEST

Thank you for your participation in the Little Miss and Little Mister Contest. Your registration has been received, and the following information will assist you and your contestant to prepare for the big event.

The Summer's End Festival Little Miss and Little Mister winners will be crowned on the porch/stage of the new Town Park Pavilion on Friday evening, August 21, 2020 at 7:00 p.m. Please arrive by 6:45 p.m.

The winners of this contest are the people's choice who have voted by giving monetary donations. One girl and one boy who raise the most money through donations will be chosen as Little Miss and Little Mister. Proceeds from this event will support the organized events and projects of the Rossville Business Association such as the Summer's End Festival fireworks, academic scholarships for Rossville students pursuing advanced degrees, sponsorships, and donations to community events such as the annual Girl Scout Easter egg hunt.

GUIDELINES:

1. This packet has three pages: Guidelines, biography page, and release form. The biography page and the release form are to be mailed to the **Rossville Business Association, Attention: Bev Miller, P.O. Box 224, Rossville, IN 46065**. There is a checklist at the bottom of the release form. Use this checklist to verify that all the requested information has been completed and returned by the deadline.

Guidelines: Please read all the information thoroughly. If you have any questions, please contact Bev Miller at 765-258-3177.

Biography Page: Use this page to tell us about your child. The host may choose a few of these questions to start a casual conversation with your child during the interview portion of the contest. You may want to review these questions with your child so that he or she feels comfortable in answering them. This form is to be returned to Bev Miller by **Wednesday, July 15, 2020**.

Release Form: This form must be signed and returned to Bev Miller by **Wednesday, July 15, 2020**. If a release form has not been signed and returned, the contestant will not participate in the event.

2. Since this contest is based upon monetary donations, a collection container will be provided for each contestant. The container is provided by the Rossville Business Association and will be rotated among several businesses. **You may provide additional containers, but you are responsible for monitoring and collecting the money from YOUR OWN containers.** Money may also be collected directly from individuals. Any additional funds collected for your contestant must be submitted to Bev Miller by **Wednesday, August 19, 2020** so that the totals can be finalized before the event. Call Bev to make arrangements for submitting the money you have collected. If any checks are collected for the contest, they are to be made payable to the Rossville Business Association, or RBA, with Little Miss/Little Mister donation written on the memo line.
3. A wallet size photo of your child is to be submitted to Bev Miller by **Wednesday, July 15, 2020**. Send the photo to Rossville Business Association, Attention: Bev Miller, P.O. Box 224, Rossville, IN 46065. The contestant's name must be printed on the back of the photo. The photo will be displayed on the collection containers from the Rossville Business Association. Photos will not be returned.
4. The winners of the Little Miss / Little Mister Contest will have the opportunity to ride in the parade on Saturday morning. The parade begins at 10:00 a.m. The winners should meet Bev Miller at the Rossville High School parking lot at 9:15 a.m. Bev will assist the winners in finding the designated car in which they will be riding in the parade.
