This is a report of the special called public meeting of the Rossville Town Council on Tuesday, August 31, 2021 at 6:30 p.m. to open paving bids for the Community Crossing Matching Grant.

On call of the roll: David Severt, Jack Fingerle, and William Croto.

Also present were Chad Colby and Barth Mink.

Dave Severt called the meeting to order. Minutes from the previous meeting were reviewed. Bill Croto made a motion to amend and remove the cost to purchase the police dog, seconded by Jack Fingerle, and passed by Council.
